ORDER MAKING FINDINGS PURSUANT TO 11 USC 362(D)(4) and GRANTING MOTION FOR BAR PURSUANT TO 11 USC 362(b)(20)

THIS MATTER coming to be heard on Motion of Eastern Savings Bank, FSB, for reasons stated in open court,

IT IS HEREBY ORDERED:

1. The Court finds that the filing of the petition in this case was part of a scheme to delay and hinder Bayview Loan Servicing, LLC that involved multiple bankruptcy filings affecting the real property commonly known as 1332 W. Madison, Chicago, IL 60609.

2. During the 2-year period following the effective date of the stay being modified as to the property commonly known as 1332 W. Madison, Chicago, IL 60609, or following the date of the entry of any order dismissing this instant case No. 16-14144, whichever is earlier, there shall be a bar to refiling in rem; such that during said 2-year period, no stay shall arise in any case brought under Title 11 of the United States Code, which would prevent Bayview Loan Servicing, LLC from proceeding against said property, provided that a copy of this order and a copy of any order or notice of stay modification or order dismissing this case has been recorded with the Recorder of Deeds of Cook County, Illinois.
