#### FOURTH AMENDMENT TO MORTGAGE

- 2. <u>No Claims: Liens Unimpaired.</u> Mortgagor acknowledges that there are no existing claims, defenses or rights of set-off or recoupment whatsoever with respect to the Mortgage, Credit Agreement or any of the other loan documents to which it is a party. Mortgagor agrees that this Fourth Amendment in no way acts as a release or relinquishment of any liens in favor of the Lender securing payment of any of the Obligations.




