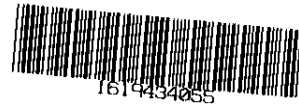

This Second Amendment to Amended and Restated Declaration of Condominium Ownership and of Easements, Restrictions, Covenants and By-Laws for Valley Lo Towers I Condominium (the "Second Amendment") is an amendment to that certain Amended and Restated Declaration of Condominium Ownership and of Easements, Restrictions, Covenants and By-Laws for Valley Lo Towers I Condominium recorded in the office of the Recorder of Deeds of Cook County, Illinois, on August 15, 2002, as Document Number 20897879, as amended from time to time ("Amended and Restated Declaration").

WITNESSETH:

WHEREAS, certain real property located in the Village of Glenview, Cook County, Illinois, has been submitted to the provisions of the Illinois Condominium Property Act (the "Act") and the Amended and Restated Declaration, such condominium being known as Valley Lo Towers I Condominium, which certain real property (the "Property") is legally described in Exhibit "A" (incorporated herein and attached hereto); and

WHEREAS, Valley Lo Towers I Condominium Association, an Illinois not-for-profit corporation (the "Association") administers the Property as set forth and described in the Amended and Restated Declaration; and

WHEREAS, the Amended and Restated Declaration has been amended by the First Amendment to Amended and Restated Declaration of Condominium Ownership and of Easements, Restrictions, Covenants and By-Laws for Valley Lo Towers I Condominium, recorded in the office of the Recorder of Deeds of Cook County, Illinois, as Document Number 21306957; and

WHEREAS, pursuant to Article 13, Section 13.06 of the Amended and Restated Declaration, the provisions of the Amended and Restated Declaration may be changed, modified or rescinded by an instrument in writing setting forth such change, modification or rescission, signed and acknowledged by the President or a Vice-President of the Board, and approved by the Unit Owners having, in the aggregate, at least sixty-seven percent (67%) of the total vote, at a meeting called for that purpose, provided, however, that all First Mortgagees have been notified by certified mail of any change, modification or rescission, and an affidavit by the Secretary of the Board certifying to such mailing is made a part of such instrument; and

WHEREAS, this Second Amendment has been signed and acknowledged by the President or a Vice-President of the Board and approved by the Unit Owners having, in the aggregate, at least sixty-seven percent (67%) of the total vote, at a meeting called for that purpose; and

WHEREAS, attached hereto is an affidavit signed by the Secretary of the Board certifying that a copy of this Second Amendment has been mailed by certified mail to all First Mortgagees.

NOW THEREFORE, the Association hereby declares that the Amended and Restated Declaration be and hereby is amended as follows.

The Association hereby declares that the Amended and Restated Declaration be and hereby is amended with regard to Article 7, and the following Section 7.01(o) is added to Article 7:

(o) Smoking shall be prohibited in all portions of the Property, including the Common Elements, the Limited Common Elements and the Units. Smoking shall mean the carrying, burning, inhaling or exhaling of any kind of lighted pipe, cigar, cigarette, hookah, weed, herbs or any other lighted smoking equipment in any manner or in any form, as well as electronic cigarettes. All Unit Owners who currently smoke inside their Units as of the effective date of this Second Amendment may continue to smoke inside their Units until such time as title to or the beneficial interest in the Unit is transferred in any manner from the current Unit Owner (including, without limitation, by sale, assignment, gift or devise). Upon such a transfer of title to or a beneficial interest in the Unit, the new Unit Owner shall be prohibited from smoking anywhere on the Property, including, without limitation, inside a Unit.

Except as expressly set forth herein, the Amended and Restated Declaration shall remain in full force and effect in accordance with its terms. The effective date of this Second Amendment shall be deemed to be the date of recording with the office of the Recorder of Deeds of Cook County, Illinois.
