WHEREAS, this Second Amendment has been signed and acknowledged by the President or a Vice-President of the Board and approved by the Unit Owners having, in the aggregate, at least sixty-seven percent (67%) of the total vote, at a meeting called for that purpose; and

WHEREAS, artached hereto is an affidavit signed by the Secretary of the Board certifying that a copy of this Second Amendment has been mailed by certified mail to all First Mortgagees.

The Association hereby declares that the Amended and Restated Declaration be and hereby is amended with regard to Article 7, and the following Section 7.01(o) is added to Article 7:

Elements, the Limited Common Elements and the Units. Shoking shall mean the carrying, burning, inhaling or exhaling of any kind of lighted pipe, cigar, cigar cite, hookah, weed, herbs or any other lighted smoking equipment in any manner or in any form, as well as electronic cigarettes. All Unit Owners who currently smoke inside their Units as of the effective date of this Second Amendment may continue to smoke inside their Units until such time as title to or the beneficial interest in the Unit is transferred in any manner from the current Unit Owner (including without limitation, by sale, assignment, gift or devise). Upon such a transfer of title to or a beneficial interest in the Unit, the new Unit Owner shall be prohibited from smoking anywhere on the Prorerty, including, without limitation, inside a Unit.

Except as expressly set forth herein, the Amended and Restated Declaration shall remain in full force and effect in accordance with its terms. The effective date of this Second Amendment shall be deemed to be the date of recording with the office of the Recorder of Deeds of Cook County, Illinois.
