MODIFICATION. Lender and Grantor hereby modify the Mortgage as follows:

The term "Specific Debt" means the promissory note dated April 1, 2016, in the original principal amount of \$30,316.96 from Williams Insurance Group, Inc. and Elliott L Williams (Borrower) to Lender, together with all renewals of, extensions of, modifications of, refinancings of, consolidations of, and substitutions for the promissory note or agreement. The interest rate on the Note is 5.750% based on a year of 360 days. Payments on the Note are to be made in accordance with the following payment schedule: in 19 regular payments of \$1,600.00 each and one irregular last payment estimated at \$1,484.08. Borrower's first payment is due May 1, 2016, and all subsequent payments are due on the same day of each month after that.
