MODIFICATION OF MORTGAGE

THIS MODIFICATION OF MORTGAGE dated April 1, 2016, is made and executed between Elliott Williams (referred to below as "Grantor") and Centrue Bank, whose address is 208 E Veterans Pkwy, Yorkville, IL 60560 (referred to below as "Lender").

MODIFICATION. Lender and Grantor hereby modify the Mortgage as follows:

The term "Specific Debt" means the promissory note dated April 1, 2016, in the original principal amount of \$30,316.96 from Williams Insurance Group, Inc. and Elliott L Williams (Borrower) to Lender, together with all renewals of, extensions of, modifications of, refinancings of, consolidations of, and substitutions for the promissory note or agreement. The interest rate on the Note is 5.750% based on a year of 360 days. Payments on the Note are to be made in accordance with the following payment schedule: in 19 regular payments of \$1,600.00 each and one irregular last payment estimated at \$1,484.08. Borrower's first payment is due May 1, 2016, and all subsequent payments are due on the same day of each month after that. Borrower's final payment will be due on December 1, 2017, and will be for all principal and all accrued interest not yet paid. Payments include principal and interest. The maturity date of the Note is December 1, 2017.

CONTINUING VALIDITY. Except as expressly modified above, the terms of the original Mortgage shall remain unchanged and in full force and effect and are legally valid, binding, and enforceable in accordance with their respective terms. Consent by Lender to this Modification does not waive Lender's right to require strict performance of the Mortgage as changed above nor obligate Lender to make any future modifications. Nothing in this Modification shall constitute a satisfaction of the promissory note or other credit agreement secured by the Mortgage (the "Note"). It is the intention of Lender to retain as liable all parties to the Mortgage and all parties, makers and endorsers to the Note, including accommodation parties, unless a party is expressly released by Lender in writing. Any maker or endorser, including accommodation makers, shall not be released by virtue of this Modification. If any person who signed the original Mortgage does not sign this Modification, then all persons signing below acknowledge that this Modification is given conditionally, based on the representation to Lender that the non-signing person consents to the changes and provisions of this Modification or otherwise will not be released by it. This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.
