MEMORANDUM OF LEASE

THIS MEMORANDUM OF LEASE (this "Memorandum") is made and entered into as of _______, 2016, by and between STAR WEST CHICAGO RIDGE, LLC, a Delaware limited liability company, whose present address is c/o Starwood Retail Partners, LLC, One East Wacker Drive, Sune 3700, Chicago, Illinois 60601 ("Landlord") and RED ROBIN INTERNATIONAL, INC., a Nevada corporation, whose present address is 6312 S. Fiddler's Green Circle, Suite 200 N, Greenwood Vilage, Colorado 80111 ("Tenant"), with reference to the following facts:

- A. Landlord is the owner of that certain real property located in the City of Chicago Ridge, County of Cook, State of Illinois, shown on <u>Exhibit A</u> hereto, and which property is more particularly described in <u>Exhibit B</u>, both of which are incorporated herein by reference (the "**Property**").
- B. Landlord desires to lease a portion of the Property to Tenant, which portion is described as the Premises in the Lease, and Tenant desires to lease the Premises from Landlord, all subject to the terms and provisions of this Memorandum.

NOW, THEREFORE, the parties hereto hereby agree as follows:

- 1. <u>Lease of the Property</u>. Landlord hereby leases the Premises to Tenant, and Tenant hereby leases the Premises from Landlord, subject to and on terms and conditions more fully set forth in that certain Lease executed by and between Landlord and Tenant and dated May 20, 2016 (the "Lease") for a term of fifteen (15) years with options to extend for two (2) successive terms of five (5) years each.
- 2. <u>No Build Area</u>. Landlord shall not (i) erect, construct, or install or allow to be erected, constructed, or installed (either permanent or temporary in nature) any buildings, signage or other structure or improvements in the "No Build Area" depicted on <u>Exhibit C</u> attached hereto and made a part hereof, (ii) make any changes in the No Build Area without the approval of Tenant, which Tenant may withhold in its sole discretion, or (iii) allow any obstruction to the visibility of the Premises from the No Build Area, the Common Area, any customer parking, or any street adjoining the Shopping Center.




