- 6. The plat of survey attached hereto as Exhibit E shall amend and replace the plat of survey originally attached to the Declaration as Exhibit E.
- 7. This First Amendment to the Declaration shall be effective upon recordation in the Office of the Recorder of Deeds of Cook County, Illinois.
- 8. Capitalized terms used but not defined herein shall have the meanings assigned to them in the Declaration.
- 9. Except to the extent expressly set forth hereinabove, the remaining provisions of the Declaration shall continue in effect without change.
