ASSIGNMENT OF RECLIVER'S CERTIFICATE LIEN

In consideration of \$10.00, in hand paid and acknowledged, NHS Redevelopment Corporation ("NHSRC") hereby assigns and transfers to the <u>CITY OF CHICAGO</u>, the <u>Receiver's Certificate Lien recorded on May 16</u>, 2013, as Document No. 1313612133, in the Office of the Cook County Recorder of Deeds.
