If Borrower fails to maintain any of the coverages described above, Lender may obtain insurance coverage, at Lender's option and Borrower's expense. Lender is under no obligation to purchase any particular type or amount of coverage. 9. Protection of Lender's Interest in the Property and Rights Under this Security Instrument. Borrower shall comply with all laws, ordinances, regulations and requirements of any governmental body applicable to the Property.
- C. SUBOPDINATE LIENS. Except as permitted by federal law, Borrower shall not allow any lien inferior to the Security Instrument to be perfected against the Property without Lender's prior written permission.
 - D. "BORROWER'S RIGHT TO REINSTATE" DELETED, Section 19 is deleted.

This assignment of Rents constitutes an absolute assignment and not an assignment for additional security only.

If Lender gives notice of default to Borrower: (i) all Rents received by Forrower shall be held by Borrower as trustee for the benefit of Lender only, to be applied to the sum; secured by the Security Instrument; (ii) Lender shall be entitled to collect and receive all of the Rents of the F operty; (iii) Borrower agrees that each tenant of the Property shall pay all Rents due and unpaid to Lender or Linder's agents upon Lender's written demand to the tenant; (iv) unless applicable law provides otherwise, all Por's collected by Lender or Lender's agents shall be applied first to the costs of taking control of and managing the Property and collecting the Rents, including, but not limited to, attorney's fees, receiver's fees, premiums (a receiver's bonds, repair and maintenance costs, insurance premiums, taxes, assessments and other charg is on the Property, and then to the sums secured by the Security Instrument; (v) Lender, Lender's agents or any judicially appointed receiver shall be liable to account for only those Rents actually received; and (vi) Lender shall be entitled to have a receiver appointed to take possession of and manage the Property and collect the Rents and profits derived from the Property without any showing as to the inadequacy of the Property as security.
