1. Payment of Principal, Interest, Escrow Items, Prepayment Charges, and Late Charges. In the event of loss, Borrower shall give prompt notice to the insurance carrier and Lender. Lender may make proof of loss if not made promptly by Borrower. Lender can no longer require loss reserve payments if Mortgage Insurance coverage (in the amount and for the period that Lender requires) provided by an insurer selected by Lender again becomes available, is the ained, and Lender requires separately designated payments toward the premiums for Morigage Insurance. If Lender required Mortgar, Insurance as a condition of making the Loan and Borrower was required to make separately designated payments toward the premiums for Mo tgage Insurance, Burrower shall pay the premiums required to maintain Mortgage Insurance in effect, or to provide a non-refundable for re erve, until Lender's requirement for Mortgage Insurance ends in accordance with any written agreement between Borrower and Lender p. ev ding for such termination or until termination is required by Applicable Law. Nothing in this Section 10 affects Borrower's obligation to pay prefest at the rate provided in the Note.

Mortgage Insurance reimburses I ender (or any entity that purchases the Note) for certain losses it may incur if Borrower does not repay the Loan as agreed. Borrower is not a justy to the Mortgage Insurance.

- C. Public Liability Insurance. Borrower shall take such actions as may be reasonable to insure that the Owners Association maintains a public liability insurance policy acceptable in form, amount, and extent of coverage to Lender.
- D. Condemnation. The proceeds of any award or claim for damages, an act or consequential, payable to Borrower in connection with any condemnation or other taking of all or any part of the Property, whether of the unit or of the common elements, or for any conveyance in lieu of condemnation, are hereby assigned and shall be paid to Lender. Such proceeds shall be applied by Lender to the sums secured by the Security Instrument as provided in Section 11.
- E. Lender's Prior Consent. Borrower shall not, except after notice to Lender and with Londer's prior written consent, either partition or subdivide the Property or consent to: (i) the abandonment or termination of the Condominium Project, except for abandonment or termination required by law in the case of substantial destruction by fire or other casualty or in the case of a taking by condemnation or eminent domain; (ii) any amendment to any provision of the Constituent Documents if the provision is for the express benefit of Lender; (iii) termination of professional management and assumption of self-management of the Owners

Association; or (iv) any action which would have the effect of rendering the public liability insurance coverage maintained by the Owners Association unacceptable to Lender.

F. Remedies. If Borrower does not pay condominium dues and assessments when due, then Lender may pay them. Any amounts disbursed by Lender under this paragraph F shall become additional debt of Borrower secured by the Security Instrument. Unless Borrower and Lender agree to other terms of payment, these amounts shall over interest from the date of disbursement at the Note rate and shall be payable, with interest, upon notice from 1 order to Borrower requesting payment.
