#### **RELEASE OF EASEMENT**

WHEREAS, an easement was reserved for the benefit of COMMONWEALTH EDISON COMPANY, a corporation organized and existing under the laws of the State of Illinois (hereinafter referred to as "ComEd"), pursuant to an Ordinance recorded in the Office of the Recorder of Deeds of Cook County, Illinois on July 22, 2016 as Document No. 14269 15258 (hereinafter referred to as the "Easement Document"). In accepting this Release of Easement, Baker Lincoln HRD, LLC (hereinafter referred to as "Grantee") acknowledges that ComEd is hereby forever released of all obligations and duties under said Easement Document and may abandon in place any of its facilities currently located in said Easement Area, and all right, title and interest to such facilities shall be transferred to Grantee.

This Release of Easement shall inure to the benefit of and be binding upon the parties hereto, their respective grantees, successors and assigns.
