SUBORDINATION AGREEMENT

WHEREAS, Courtney Johnson (the "Owner") has provided to Great Lakes Credit Union, a mortgage (the "Senior Mortgage") dated May 24, 2014 and recorded in the Recorder's Office of Cook County, Illinois on May 31, 2016 as Document No. 1615247074, encumbering certain premises in Cook County, Illinois legally described on Exhibit A attached hereto (the "Premises") to secure a promissory note not to exceed **Two Hundred Five Thousand Dollars and 00/100 (\$205,000.00)**, with interest payable as provided therein.

WHEREAS, the Owner has previously provided to Illinois Housing Development Authority (the "Authority") a Recapture Agreement dated **October 20, 2012** and recorded on **May 3, 2013** as Document No. **1312301107** modified by Document No. **1408541025** recorded on **March 26, 2014** with the Office of the Recorder of Deeds of Cook County (the "Recapture Agreement").


WHEREAS, the Owner wishes to subordinate the lien of the Recapture Agreement to the lien of the Senior Mortgage.

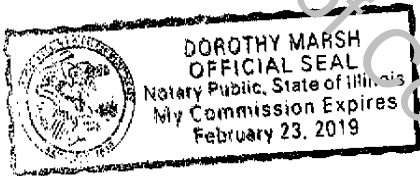
