MODIFICATION OF MORTGAGE

THIS MODIFICATION OF MORTGAGE dated August 15, 2016, is made and executed between TBS GREENVIEW I, L.L.C., an Illinois Limited Liability Company whose address is 3754 NORTH SOUTHPORT AVENUE, CHICAGO, IL 606133719 (referred to below as "Grantor") and FIRST MIDWEST BANK, whose address is ONE PIERCE PLACE, SUITE 1500, ITASCA, IL 60143 (referred to below as "Lender").

2. To amend the Real Property tax identification number as stated above.
3. To delete the definition of Note in its entirety and insert in lieu thereof the following: "Note. The word "Note" means the promissory note dated August 15, 2016 in the original principal amount of \$6,000,000.00 from Borrower to Lender, together with all renewals of, extensions of, modifications of, refinancings of, consolidations of and substitutions for the promissory note or agreement. CONTINUING VALIDITY. Except as expressly modified above, the terms of the original Mortgage shall remain unchanged and in full force and effect and are legally valid, binding, and enforceable in accordance with their respective terms. Consent by Lender to this Modification does not waive Lender's right to require strict performance of the Mortgage as changed above nor obligate Lender to make any future modifications. Nothing in this Modification shall constitute a satisfaction of the promissory note or other credit agreement secured by the Mortgage (the "Note"). It is the intention of Lender to retain as liable all parties to the Mortgage and all parties, makers and endorsers to the Note, including accommodation parties, unless a party is expressly released by Lender in writing. Any maker or endorser, including accommodation makers, shall not be released by virtue of this Modification.
