AMENDMENT TO DECL ARATION OF CONDOMINIUM OWNERSHIP AND BYLAWS, FASEMENTS, RESTRICTIONS AND COVENANTS FOR MERRIM AC SQUARE CONDOMINIUM II

This document is recorded for the purpose of amending the Declaration of Condominium Ownership and Bylaws, Easements, Restrictions and Covenants for Merrimac Square Condominium II (hereinafter the "Declaration"), waiter was recorded in the Office of the Recorder of Deeds of Cook County, Illinois, on September 28, 1992, as Document Number 0526318012, and covers the property located at 6526 W. WHEREAS, the Merrimac Square Condominium II Association wishes that the Declaration be amended in order to change the allocation of two (2) Parking Spaces Limited

Element ("Parking Space(s)") as delineated on the Survey attached to the Declaration as Exhibit "B";

WHEREAS, pursuant to Paragraph 6 of Article XIX of the Declaration, the Declaration may be amended, changed or modified by an instrument in writing setting forth such amendment, change or modification, signed and acknowledged by all the members of the Board of the Directors of the Merrimac Square Condominium II Association; and

WHEREAS, the Amendment to the Declaration was approved by at least three-fourths (3/4) of the unit owners at a duly called special meeting held on May 18, 2016.

NOW DIEREFORE, the Declaration is hereby amended as follows:

- (1) EXHIBIT "2" SURVEY, is hereby amended as follows:
 - The Owner of Unit 308 shall have the exclusive right to the use of Parking Space No. P-35, a Limited Common Element as delineated on the Survey attached to the Declaration as Exhibit "B". Par'ing Space P-35 shall be assigned as a Parking Space Limited Common Element to Unit 308;
 - The Owner of Unit 505 shall have the exclusive right to the use of Parking Space No. P-9, a Limited Common Element at delineated on the Survey attached to the Declaration as Exhibit "B". Parking Space P-9 shall be assigned as a Parking Space Limited Common Element to Unit 505.

This Amendment shall be effective upon recordation in the Office of the Recorder of Deeds of Cook County, Illinois.

Except to the extent expressly set forth hereinabove, the remaining provisions of the Declaration shall continue in effect without change.
