NOW, THEREFORE, the Declaration is hereby amended as follows (additions in text are indicated by <u>double underline</u> and deletions in text are indicated by <u>strike-out</u>):

#### 1. Article XI, Section 11.01

Violations of Restrictions, Easements, Conditions, Covenants, Liens and Charges. The Association or any Owner shall have the right to enforce, by any proceeding at law or in equity, all restrictions, easements, conditions, covenants, liens and charges now or hereafter imposed by the provisions of this Declaration. Any Gwner found to be in violation by the Board of Directors or by a court of connectent jurisdiction of any of the governing documents foregoing shall also be liable for reasonable all attorney's fees incurred by the Association resulting from such violation. in prosecuting such action. The amount of such attorney's fees together with court costs, if unpaid, shall constitute an additional lien against the defaulting Owner's Assessment Parcel, enforceable as other liens herein established. Faiture by the Association or by any Owner to enforce any covenant or restriction herein contained shall in no event be deemed a waiver of the right to do so thereafter.

This Amendment shall be effective upon recordation in the Office of the Recorder of Deeds of Cook County, Illinois.

Except to the extent expressly set forth hereing bove, the remaining provisions of the Declaration shall continue in effect without change.
