EXHIBIT A**LEGAL DESCRIPTION:**

Lots 90 and 91 in Block 1, Rumberford's Third Addition to Mount Clare in the Northwest $\frac{1}{4}$ of Section 30, Township 40 North Range 13 East of the Third Principal Meridian, in Cook County, Illinois, except for that part thereof taken for street purposes in Case No. 83 L 51231 described as follows: Beginning at the southwest corner of Lot 91; thence on an assumed bearing North 00 degrees 00 minutes 00 seconds east along the westerly line of said lot 91, a distance of 42.25 feet to a point on a 25.00 foot radius curve, the center of said curve bears north 90 degrees 00 minutes 00 seconds east from said point; thence southeasterly along said curve through a central angle of 80 degrees 51 minutes 40 seconds for a distance of 35.28 feet; thence south 30 degrees 51 minutes 48 seconds east 79.98 feet to the east line of the said lot 90; thence north 00 degrees 00 minutes 00 seconds west along the east line of said lot 90, 5.61 feet to the south line of said lot 90; thence north 89 degrees 27 minutes 30 seconds west along the south line of said lots 90 and 91, a distance of 100 feet to the point of beginning.
