## POWER OF ATTORNEY made by Steven E. Lewis

POWER OF ATTORNEY is effective as of the fourteenth day of September 2016 (the "Effective Date").

I, **Steven E. Lewis** (residing at 502 South Windsor Blvd., Los Angeles, CA 90020), hereby appoint **Cory J. Lewis** (residing at 663 West Wellington Ave., Unit 4, Chicago, IL 60657) as my attorney-in-fact (my "Agent") to act for me and in my name (in any way I could act in person), to the extent permissible under the laws of the State of Illinois, with respect to any and all transactions, arrangements, meetings, correspondence, or other related events in furtherance of, pursuant to, or in any way related to, the refinancing (the "Mortgage Refinancing") of the existing home mortgage loan for 663 West Wellington Avenue, Unit 4, Chicago, Illinois 60657 (the "Current Mortgage"), to which I am a co-borrower and co-signor, as the case may be, along with Marjorie E. Lewis, Ashley H. Lewis, or Caitlyn R. Lewis.

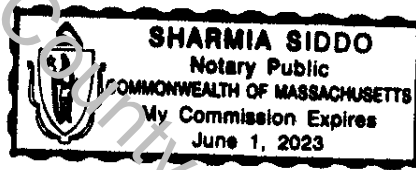
