#### **AMENDMENT TO LOAN DOCUMENTS**

1.1 <u>Cross Collateralization / Cross Default</u>. Borrower acknowledges and agrees that (A) any and all collateral pledged as security in favor of Lender pursuant to the Revolving Loan Documents secures the Indebtedness; (B) any and all collateral pledged as security in favor of Lender pursuant to the Term Loan Documents secures the Indebtedness; (C) Lender shall not release any lien on any Collateral unless and until all the Indebtedness is paid in full; (D) any "Default" or "Event of P Default" under the Revolving Loan Documents shall be a default under the Term Loan Documents;
