

ASSIGNMENT OF RECEIVER'S CERTIFICATE LIEN

Pursuant to the ordinance passed by the City Council of Chicago Journal of Proceedings, July 9, 2003, at pg.3548, as amended from time to time thereafter authorizing the same, the City of Chicago, by the Commissioner of the Department of Planning and Development, hereby assigns and transfers to COMMUNITY INITIATIVES, INC., the Receiver's certificate Lien recorded November 26, 2013 as document number #1332901077 with the Cook County Recorder of deeds. Said lien arises out of the cause known as City of Chicago vs. Leona Farrell, et al., case no. #11M1400617. Zv. suant to the court order entered on October 24, 2013 the receiver issued a receiver's certificate in the amount of \$7,655.50 bearing ar interest rate of (9%) per annum for costs and fees until paid, and transferred to the City of Chicago on October 24, 2013 and pursuant to 65 ILCS 5/11-31-2, constitutes a first lien on the subject premises, superior to all other encumbrances, except taxes, against the real estate legally described herein below.
