The Credit Line Agreement in the amount of \$105,500.00 executed by Mortgagor/Grantor and dated the same date as this Security Instrument, which, if not paid earlier, is due and payable in full 300 months from the due date of the first payment.

- B. All future advances from Lender to Mortgagor or other future obligations of Mortgagor to Lender under any promised various, contract, guaranty, or other evidence of debt executed by Mortgagor in favor of Lender executed after an security Instrument whether or not this Security Instrument is specifically referenced.
