**MODIFICATION.** Lender and Grantor hereby modify the Mortgage as follows:

The definition of the Note in the Definitions section is deleted and the following definition substituted in its place: The word "Note" means the Promissory Note dated July 5, 2012, in the original principal amount of \$1,500,000.00 from Borrower to Lender, together with all renewals of, extensions of, modifications of, refinancings of, consolidations of, restatements of and substitutions for the Note, including but not limited to the Change in Terms dated January 5, 2014 wherein the principal amount of the Note is increased to \$2,500,000.00, Change in Terms dated March 11, 2014 wherein the principal amount of the Note is increased to \$2,750,000.00 and Change in Terms dated August 5, 2016 wherein the principal amount of the Note is increased to \$3,250,000.00, all of which are incorporated herein by this reference as if fully restated herein. Borrower's final payment of such Note will be for all unpaid principal and all unpaid accrued interest. The following PINs: 14-20-228-039-1001 (Unit 3609-1), 14-20-228-039-1002 (Unit 3609-2), 14-20-228-039-1003 (Unit 3609-3), 14-20-228-039-1004 (Unit 3611-1), 14-20-228-039-1005 (Unit 3611-2), 14-20-228-039-1006 (Unit 3611-3) are removed and replaced by PIN 14-20-228-042-0000.

**CONTINUING VALIDITY.** Except as expressly modified above, the terms of the original Mortgage shall remain unchanged and in full force and effect and are legally valid, binding, and enforceable in accordance with their respective terms. Consent by Lender to this Modification does not waive Lender's right to require strict performance of the Mortgage as changed above nor obligate Lender to make any future modifications. Nothing in this Modification shall constitute a satisfaction of the promissory note or other credit agreement secured by the Mortgage (the "Note"). It is the intention of Lender to retain as liable all parties to the Mortgage and all parties, makers and endorsers to the Note, including accommodation parties, unless a party is expressly released by Lender in writing. Any maker or endorser, including accommodation makers, shall not be released by virtue of this Modification. If any person who signed the original Mortgage does not sign this Modification, then all persons signing below acknowledge that this Modification is given conditionally, based on the representation to Lender that the non-signing person consents to the changes and provisions of this Modification or otherwise will not be released by it. This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.
