

The Funds shall be held in an institution whose deposits are insured by a federal agency, instrumentality, or entity (including Lender, if Lender is an institution whose deposits are so insured) or in any Federal Home Loan Bank. 

Borrower subject to Lender's right to disapprove Borrower's choice, which right shall not be exercised unreasonably. Such loss reserve shall be non-refundable, not wit istanding the fact that the Loan is ultimately paid in full, and Lender shall not be required to pay Borrower any interest or earnings on such loss reserve. 




