ALL THAT PART OF LOT 16 IN BERNARD KLOEPFER'S RESUBDIVISION OF PART OF THE WEST 1/2 OF SECTION 29, TOWNSHIP 42 NORTH, RANGE 13, EAST OF THE THIRD PRINCIPAL MERIDIAN AND THAT PART OF THE WEST 1/2 OF THE NORTHWEST 1/4 OF SAID SECTION 29, LYING SOUTH OF AND ADJOINING SAID LOT 16, DESCRIBED AS FOLLOWS:
