In all exercises of gift transaction powers, my Attorney in Fact shall take into account the potential offect of gift or bargain transfers on my existing or future eligibility for Medicaid and other public benefits programs:

- 19. ALL OTHER MATTERS. Authority with respect to all other matters pursuant to Indiana Code 30-5-5-19.

**GUARDIANSHIP.** If it becomes necessary to secure the appointment of a guardian of my person or estate, or if protective proceedings are filed on my behalf, I hereby request that the appropriate probate court appoint James L. Willis as my guardian or as the person to act on my behalf.

SUPERSEDES PRIOR POWERS OF ATTORNEY. This Power of Attorney supersedes all other powers of attorney I have executed prior to the date of this Power of Attorney.

**TERMINATION AT DEATH.** Without regard to my mental or physical condition, this Power of Attorney shall continue in effect until revoked or until my death, whichever occurs first.
