- 2. Payment of Property Charges. Borrower shall not commic waste or destroy, damage or substantially change the Property or allow the Property to deteriorate, reasonable wear and tear excepted. - e. The Note is not eligible to be called due and payable for any other reason.

- (c) Due and Payable with Secretary Approval. Lender may require immediate payment in full of all sums secured by this Secretary Instrument, upon approval of the Secretary, if:
 - (i) The Property ceases to be the Principal Residence of a Borrower for reasons other than death and the Property is not the Principal Residence of at least one other Borrower; or
 - (ii) For a period of longer than twelve (12) consecutive months, a Borrower fails to occupy the Property because of physical or mental illness and the Property is not the Principal Residence of at least one other Borrower or

A deferral of due and payable status is not permitted when a Lender requires immediate payment in full under Paragraph 10(c).

- (d) Notice and Certification to Lender. Borrower shall complete and provide to the Lender on an annual basis a certification, in a form prescribed by the Lender, stating whether the Property remains the Borrower's Principal Residence and, if applicable, the Principal Residence of his or her Non-Borrowing Spouse. Where a Borrower has identified a Non-Borrowing Spouse in Paragraph 9 and the identified Non-Borrowing Spouse qualifies as an Eligible Non-Borrowing Spouse, the Borrower shall also complete and provide to the Lender on an annual basis an Eligible Non-Borrowing Spouse certification, in a form prescribed by the Lender, certifying that all requirements for the application of a Deferral Period continue to apply and continue to be met. - (g) Trusts. - (h) Mortgage Not Insured. - 11. No Deficiency Judgments. Borrower shall have no personal liability for payment of the debt secured by this Security Instrument. Lender may enforce the debt only through sale of the Property. Lender shall not be permitted to obtain a deficiency judgment against Borrower if the Security Instrument is foreclosed. - 23. Foreclosure Procedure of Lender requires immediate payment in full under Paragraph 10, Lender may foreclose this security Instrument by judicial proceeding.
