If Borrower acquires fee title to the Property, the leasehold and the fee title shall not merge unless Lender agrees to the merger in writing.

10. Mortgage Insurance. If Lender require d Nortgage Insurance as a condition of making the Loan, Borrower shall pay the premiums required to maintain the Mirtgig. Insurance in effect. If, for any reason, the Mortgage Insurance coverage required by Lender ceases to be availar as from the mortgage insurer that previously provided such insurance and Borrower was required to make separately de igna'ed payments toward the premiums for Mortgage Insurance, Borrower shall pay the premiums required to obtain correrage substantially equivalent to the Mortgage Insurance previously in effect, at a cost substantially equivalent of the Borrower of the Mortgage Insurance previously in effect, from an alternate mortgage insurer selected by Tender. If Lender outchases insurance for the collateral, Borrower will be responsible for the costs of that insurance, including interestical any other charges Lender may impose in connection with the placement of the insurance, until the effective date of the cancellation or expiration of the insurance. The costs of the insurance may be added to Borrower's total outstanding balance or obligation. The costs of the insurance may be more than the cost of insurance Borrower may be able to obtain on its own.
