 - B. As of the Modification Effective Date, the new principal balance of my Note is \$91,319.13 (the "New Principal Balance"). In servicing your loan, the Bank may have incurred third-party fees or charges that were not included in the terms of this Agreement. If so, these fees and charges will appear on your monthly statement under "Fees and Charges". These fees and charges will not accrue interest or late fees. You may pay these fees and charges at any time.
