CONSTRUCTION MORTGAGE, ASSIGNMENT OF RENTS AND LEASES, SECURITY AGREEMENT AND FIXTURE FILING

THIS MORTGAGE SECURES FUTURE ADVANCES IN ACCORDANCE WITH THE TERMS OF THE CONSTRUCTION LOAN AGREEMENT (AS HEREINAFTER DEFINED).

DEFINITIONS

- (A) "Borrower" is DSMR CONSULTANTS LLC. Borrower is a limited liability company, organized and existing under the laws of Nevada. Borrower's address is 9436 Steger Road, Frankfort, Illinois 60423. Borrower is the Mortgagor under the Mortgage(s).
- (B) "Lender" is PS FUNDING, INC. Lender is a corporation, organized and existing under the laws of Delaware. Lender's address is 300 Manhattan Beach Boulevard, Suite 205, Manhattan Beach, California 90266. Lender is the Mortgagee under the Mortgage(s).
- (C) "Loan" means the debt evidenced by the Note, plus interest, any prepayment charges and late charges due under the Note, and all sums due under the Mortgage(c).

The coverage that Lender purchases may not pay any claim that Mortgagor makes or any claim that is made against Mortgagor in connection with the collateral. Mortgagor may later cancel any insurance purchased by Lender, but only after providing Lender with evidence that Mortgagor has obtained insurance as required by Mortgagor's and Lender's agreement. If Lender purchases insurance for the collateral, Mortgagor will be responsible for the costs of that insurance, including interest and any other charges Lender may impose in connection with the placement of the insurance, until the effective date of the cancellation or expiration of the insurance. Choice of Law. Illinois law shall exclusively govern the enforcement and interpretation of this Mortgage.
