which Note, together with interest thereon as therein provided, is payable in monthly installments of
ONE THOUSAND EIGHTY-THREE AND 48/100 DOLLARS (\$ ***1,083.48***),
commencing on the ***FIRST*** (**** ST****) day of FEBRUARY , 20_17 , which amount may change
annually beginning on FEBRUARY 1, 2018 to reflect changes in the interest rate in effect from time to time, and
which payments are to be applied, first, to interest, and the balance to principal, until said indebtedness is paid in full.
(2) The interest rate the Mortgagor will pay may change on the **FIRST** (**1st**) day of FEBRUARY, 20 18, and on that day of the month every ***TWELVE*** (***12***) months thereafter. Each date on which the interest rate could change is called a "Change Date". Beginning with the first Change Date, the interest rate will be based on an "Index". The Index is the weekly average yield on United States Treasury Securities adjusted to a constant maturity of ***ONE*** (***1***) year, as made available by the Federal Reserve Board. The most recent Index figure available as of 45 days before each Change Date is called the "Current Index". If the Index is no longer available, the Mortgagee will choose a new Index which is based upon comparable information. The Mortgagee will give the Mortgagor notice of its choice.
(3) Before each Change Date the Mortgagee will calculate the new interest rate by adding **THREE AND ONE-QUARTER** percentage points (****3.25%*****) to ne Corrent Index. The sum will be the new interest rate. Notwithstanding the foregoing, the minimum interest rate charged upon the Note on each Change Date will be ****FOUR AND ONE-QUARTER**** percent (****4.25%*****) per annum. The Mortgage will then determine the amount of the monthly payment that would be sufficient to repay in full the principal the Mortgagor is expected to owe on the Change Date in substantially equal payments based upon the remaining amortization period of the loan at the new interest rate. The result of this calculation will be the new amount of the monthly payment. The new interest rate will become effective on each Change Date. The Mortgagor will pay the amount of the new monthly payment beginning on each Change Date until the amount of the monthly payment changes again.
(4) Monthly payments will be considered delinquent and in deau't if the full amount of any monthly payment is not received by the end of the 20th day of the month or on the preceding business day if the 20th falls on a legal holiday or non-business day. Whenever all of the indebtedness secured hereby is paid, and the Mortgagee, in its sole discretion, feels that there is no substantial uncorrected default in performance of the Mortgagor's agreements herein, the Mortgagee, on satisfactory evidence thereof, shall relinquish possession and pay to Mortgagor any surplus income in its hands.
