- 1. Payment of Principal. Mortgagor shall pay, when due, the principal on the indebtedness evidenced by the Note, any fees and costs provided in the Note, and all other sums secured by this Mortgage.
- 2. Application of Payments. Unless applicable law requires otherwise, all payments received by Lender from Mortgagor under the Note or this Mortgage shall be applied by Lender in the following order of priority: (a) costs payable as provided in the Note and then principal of the Note.
- 3. Charges; Liens. Fortgagor shall pay all water and sewer rates, rents, taxes, assessments, insurance premiums, and other impositions attributable to the Property, when due, directly to the appropriate payee.
