WHEREAS, OWNER has executed, or is about to execute, a mortgage and note not to exceed the amount of \$293,936.00, in favor of Wells Fargo Bank, N.A., ISAOA, ATIMA hereinafter referred to as "LENDER", payable with interest and upon the terms and conditions described therein, which mortgage has yet to be recorded, and

WHEREAS, it is a condition precedent to obtaining said loan that said mortgage above mentioned shall unconditionally remain at all times, a lien or charge upon the land hereinbefore described, prior and superior to the lien or charge of the mortgage first above mentioned, and

- (1.)That said mortgage securing said note in favor of LENDER, and any renewals or extensions thereof, shall unconditionally be and remain at all times a lien or charge on the property therein described, prior and superior to the lien or charge of the mortgage first above described.
- (2.)That LENDER would not make its loan above described without this SUBORDINATION AGREEMENT.
- (3.)That this agreement shall be the whole and only agreement with regard to the subordination of the lien or charge of the mortgage first above mentioned to the lien or charge of the mortgage in favor of the LENDER above referred to and shall supersede and cancel, but only insofar as would affect the priority between the mortgages hereinbefore specifically described, any prior agreement as to si ch subordination including, but not limited, those provisions, if any, contained in the mortgage r'st above mentioned, which provide for the subordination of the lien or charge thereof to another mortgage or mortgages or to another deed or deeds of trust.
- LENDER vill notify MORTGAGEE in writing if an event of default exists, within ten days of the (4.)occurrence of the event.
- (5.)Payments on the note in a vor of MORTGAGEE may be made so long as MORTGAGEE has not received a notice from the LENDER that an event of default exists.
