MEMORANDUM OF LEASE

BE IT KNOWN, that Lake Shore Country Club, an Illinois not-for-profit corporation having a mailing address of 1255 Sheridan Road, Clencoe, Illinois 60022 ("Lessor") and Crown Castle NG Central LLC, a Delaware limited liability company, with a mailing address of 2000 Corporate Drive, Canonsburg, Pennsylvania 15317-8564 ("Lessee") have entered into a Lease (the "Agreement") covering the area as depicted on the site sketch attached hereto as Exhibit B (the "Leased Premises") The Agreement grants unto Lessee the non-exclusive right to use the Easement Area also depicted as such and legally described on Exhibit B.
