**THIS MATTER** coming to be heard on the Motion of the Plaintiff, Sysco Chicago, Inc., a corporation, for an Order of Default and Judgment against the Defendant, Fratelloshomewood, Inc., a corporation d/b/a Fratello's, Fratello's Cafe & Deli Market, and Fratello's Catering and Cafe & Deli, on Counts II, III and IV of Plaintiff's Amended Complaint, plus costs said Defendant having been served with Summons and Complaint and having failed to appear or otherwise plead, due notice having been served and the Court being fully advised in the premises, and for good cause shown:

**IT IS HEREBY ORDERED:**

1. That the Defendant, Fratelloshomewood, Inc., a corporation d/b/a Fratello's, Fratello's Cafe & Deli Market, and Fratello's Catering and Cafe & Deli, is found to be in default for failure to appear or otherwise plead;
2. That Judgment is entered in favor of the Plaintiff, Sysco Chicago, Inc., a corporation, and against the Defendant, Fratelloshomewood, Inc., a corporation d/b/a Fratello's, Fratello's Cafe & Deli Market, and Fratello's Catering and Cafe & Deli, on Count III of Plaintiff's Amended Complaint, in the amount of \$32,556.53;
4. That Judgment is entered in favor of the Plaintiff, Sysco Chicago, Inc., a corporation, and against the Defendant, Fratelloshomewood, Inc., a corporation d/b/a Fratello's, Fratello's Cafe & Deli Market, and Fratello's Catering and Cafe & Deli, and Count IV of Plaintiff's Amended Complaint, in the amount of \$15,088.62, plus costs (\$512.00 to date); and
