SIXTH AMENDMENT TO MORTGAGE

- 1. Amendment to Mortgage. The Promissory Note dated September 21, 2012 in the original principal amount of \$659,900.00 has been modified to extend the Maturity Date to November 10, 2019 with monthly principal and interest payments of \$4,315.00 due the 10th of each month until Maturity.
- 2. <u>No Claims; Liens Unimpaired.</u> Mortgagor acknowledges that there are no existing claims, defenses or rights of set-off or recoupment whatsoever with respect to the Mortgage, Credit Agreement or any of the other loan documents to which it is a party. Mortgagor agrees that this Sixth Amendment in no way acts as a release or relinquishment of any liens in favor of the Lender securing payment of any of the Obligations.
