- a. all executory terms and conditions of the Redevelopment Agrament, and all representations and covenants contained therein remain in full force and effect, including, without limitation, the occupancy covenants set forth in Section 15 (Restrictions on Use) of the Redevelopment Agreement; and
- the issuance of this Phase I Certificate of Completion shall not be construed as a waiver by the City of any of its rights and remedies pursuant to such executory terms; and
- c. a Phase II Certificate of Completion will not be issued until the developer has satisfied the requirements under Section 14.3.
