AN ORDINANCE ANNEXING AND ZONING CERTAIN PROPERTY TO THE CITY OF COUNTRY CLUB HILLS (5000 WEST 173RD STREET/P.I.N. 28-28-409-006-0000)

WHEREAS, the property described on **Exhibit 1** attached hereto and made a part hereof (the "Subject Property") has a common address of 5000 West 173rd Street; and

WHEREAS, the Subject Property is vacant, in unincorporated Cook County, and contiguous to the City of Country Club Hills; and

WHEREAS, the Subject Property is va can; and

WHEREAS, the Petitioning Owner desires to cause the Subject Property to be annexed to the City and used for truck storage purposes; and

WHEREAS, pursuant to notice as required by law, the City of Country Club Hills Zoning Board of Appeals conducted a public hearing on the proposed annexation and zoning of the Subject Property; and

WHEREAS, the ZBA has favorably recommended the annexation and zoning subject to certain conditions; and

WHEREAS, the City Council concurs in the recommendations of the ZBA;

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF COUNTY CLUB HILLS, COOK COUNTY, ILLINOIS, IN THE EXERCISE OF THE CITY'S HOME RULE POWERS, as follows:

Section 1: Annexation. The Subject Property is hereby annexed to the City of Country

Section 2: Zoning; Conditions.

A. The Subject Property is hereby zoned into the City's M-Limited Manufacturing

District.

B. In accordance with Section 15.8.02 of the City Code and the recommendation of the

ZBA, outdoor storage of automobiles shall be screened by a solid wall or a uniformly-painted solid

fence at least eight (50) feet in height.

C. At least 40 feet of the Subject Property as measured from the entrance shall be paved

with material approved by the Building Commissioner.

D. No garbage or hazardous material shall be stored on the Subject Property.

Section 3: Plat of Annexation. The City Clerk is hereby authorized and directed to

cause a copy of this Ordinance, along with a Plat of Amexation to be recorded in the Office of the

Cook County Recorder of Deeds. The Owner of the Subject Property is responsible for the Plat

preparation costs.

Section 3: Effective Date. This Ordinance shall be in full force and effect from and after

its passage and approval, and shall subsequently be published in pamphlet form as provided by law.
