UNIFORM COVENANTS. Borrower and Lender covenant and agree as follows:

Fayment of Principal, Interest, Escrow Items, Prepayment Charges, and Late Charges. If the Index is no longer available, the Note Holder will choose a new index that is based upon comparable information. The Note Holder will give me notice of this choice.

(C) Calculation of Changes

Before each Change Date, the Note Holder will calculate my new interest rate by adding TWO AND ONE QUARTER percentage points (2.250 %) ("ine" Margin") to the Current Index.
