ORDER

This cause coming on to be heard for an award of damages based on the findings in this Court's decision issued January 15, 2016 on Count I: Conversion and Count II: Breach of Bailment in favor of plaintiff. The Court having read the briefs of the parties and no objection having been raised regarding the evidence presented, IT IS HEREBY ORDERED:

1. The Court awards compensatory damages in the amount of \$491,035.05;
2. The Court awards prejudgment interest in the amount of \$157,540.41, finding that defendant Michael Pesha wrongfully withheld the coins.
3. The Court awards punitive damages in the amount of \$1,300,000.00. The Court finds that defendant, Michael Pesha, acted willfully in converting plaintiff's property.

Plaintiff is awarded damages against Michael Pesha in the total amount of \$1,948,575.46.


