This Mortgage Rider, dated 03/04/2017 is incorporated into and amends the mortgage, deed of trust, or security deed (the Security Instrument) of the same date. The Security Instrument covers the Property described above.

Secured Debt

Secured Debt. The Secured Debt and Future Advances (sometimes referred to as Secured Debts) section of the Security Instrument is amended to add the following sentence as the last sentence in the final paragraph:



Mortgagor or Grantor will pay those amounts to Lender unless Lender tells Mortgagor or Grantor, in writing, that Mortgagor or Grantor does not have to do so, or unless the law requires otherwise. Mortgagor or Grantor will make those payment at the times required by Lender.

Lender will so mate from time to time Mortgagor or Cantor's yearly taxes, assessments, leaseneld payments or ground rents and insurance premiums, which will be called the Escrow Item. 1 ender will use existing assessments and bills and reasonable estimates of future assessments and bills. The amounts that Mortgagor or G antor pays to Lender for Escrow Items under this ection will be called the Funds. Lender will collect and hold Funds in an amount not to excerd the maximum amount a lender for a federally related mortgage loan may require for Mortgagor or Grantor's escrow account under the federal Real Estate Settlement Procedures Act of 1974 (as amended), unless another law that applies to the Funds sets a lesser amount.
