CITY OF CHICAGO'S COMPLAINT FOR EQUITABLE AND OTHER RELIEF

Plaintiff, THE CITY OF CHICACO ("the City"), by and through its attorney, Stephen R. Patton, Corporation Counsel, and the undersigned attorney, comp ains of the defendants as follows:

GENERAL ALLEGATIONS

Nature of the Case

1. The City brings this action pursuant to its police power as a home rule unit under the Illinois Constitution, article VII, § 6(a), 65 ILCS 5/11-31-1(a) e' seq. (West 2012), 65 ILCS 5/11-13-15, and provisions of the Municipal Code of Chicago. By Linging this action, the City seeks to abate dangerous and unsafe conditions at the property in question and obtain equitable relief, civil penalties, attorney's fees, and costs.

The Parties and the Property at Issue

- 2. The City is a municipal corporation organized and existing under the laws of the State of Illinois.
- 3. Within the corporate limits of Chicago, there is a parcel of real estate legally described as:

LOT 11 IN BLOCK 6 IN GAUNTLETT'S LA FRAMBOISE PARK SUBDIVISION OF PART OF THE EAST 1/2 OF THE EAST 1/2 OF FRACTIONAL SECTION 23, TOWNSHIP 40 NORTH, RANGE 12, EAST OF THE THIRD PRINCIPAL MERIDIAN, NORTH OF THE INDIAN BOUNDARY LINE IN COOK COUNTY, ILLINOIS.

This parcel is commonly known as 3547 N PARIS AVE, Chicago, Cook County, Illinois ("subject property"), and has a permanent index number of 12-23-405-010-0000.

4. Located on the subject property is a FRAME GARAGE AND TWO STORY FRAME BUILDING.
