MODIFICATION OF MORTGAGE

THIS MODIFICATION OF MORTGAGE dated February 1, 2017, is made and executed between BCHDOBSON, LLC, an Illinois Limited Liability Company (referred to below as "Grantor") and First Bank & Trust, whose address is 820 Church Street, Evanston, IL 60201 (referred to below as "Lender").

The word "Note" means the promissory note dated February 1, 2017, in the original principal amount of \$2,119,706.25 from Grantor to Lender, together with all renewals of, extensions of, modifications of, refinancings of, consolidations of, and substitutions for the promissory note or agreement. The interest rate on the Note is a variable interest rate based upon an index. The index currently is 3.750% per annum. Interest on the unpaid principal balance of the Note will be calculated using a rate of 0.500 percentage points under the Index, resulting in an initial rate of 3.250% based on a year of 360 days. Payments on the Note are to be made in accordance with the following payment schedule: in 59 principal payments of \$7,475.00 each and one final principal and interest payment of \$1,683,379.23. Grantor's first principal payment is due March 1, 2017, and all subsequent principal payments are due on the same day of each month after that. In addition, Grantor will pay regular monthly payments of all accrued unpair interest due as of each payment date, beginning March 1, 2017, with all subsequent interest payments to be due on the same day of each month after that. Grantor's final payment due February 1, 2022, will be for all principal and all accrued interest not yet paid. If the index increases, the payments tied to the incex, and therefore the total amount secured hereunder, will increase. Any variable interest rate tied to the index shall be calculated as of, and shall begin on, the commencement date indicated for the applicable payment stream. NOTICE: Under no circumstances shall the interest rate on this Note be more than the maximum rate allowed by applicable law. NOTICE TO GRANTOR: THE NOTE CONTAINS A VARIABLE INTEREST RATE.

All other terms and conditions not specifically amended herein, remain unchanged and in full effect.

CONTINUING VALIDITY. Except as expressin modified above, the terms of the original Mortgage shall remain unchanged and in full force and effect and are legally valid, binding, and enforceable in accordance with their respective terms. Consent by Lender to this Modification does not waive Lender's right to require strict performance of the Mortgage as changed above nor obligate Lender to make any future modifications. Nothing in this Modification shall constitute a satisfaction of the promissory note or other credit agreement secured by the Mortgage (the "Note"). It is the intention of Lender to retain as liable all parties to the Mortgage and all parties, makers and endorsers to the Note, including accommodation parties, unless a party is expressly released by Lender in writing. Any maker or endorser, including accommodation makers, shall not be released by virtue of this Modification. If any person who signed the original Mortgage does not sign this Modification, then all persons signing below acknowledge that this Modification is given conditionally, based on the representation to Lender that the non-signing person consents to the changes and provisions of this Modification, but also to all such subsequent actions.
