3. The name of the currently serving trustees of the above-described trust are: LORIN SPAK and ROBERT VAN STEDUM

- 4. The initial Trustee, BARBARA M. MOSE died on February 10, 2017. A death certificate may be attached to this Affidavit.
- 5. Pursuant to Section 3.03(a) of the trust, LORIN SPAK is designated as successor Trustee.
- 6. Pursuant to Section 3.05 of the trust LORIN SPAK appointed ROBERT VAN STEDUM to serve as Cotrustee. A copy of the Appointment is attached to this Affidavit.
- 7. Pursuant to Section 12.17, the Trustee is granted the following real estate powers: "My Trustee may sell at public or private sale, convey, purchase, exchange, lease for any period, mortgage, manage, alter, improve and in general deal in and with real property in such manner and on such terms and conditions as my Trustee deems appropriate. My Trustee may grant or release easements in or over, subdivide, partition, develop, raze improvements, and abandon, any real property. My Trustee may manage real estate in any manner that my Trustee deems best and shall have all other real estate powers necessary for this purpose. My Trustee may enter into contracts to sell real estate. My Trustee may enter into leases and grant options to lease trust property even though the term of the agreement extends beyond the termination of the trust and beyond the period that is required for an interest created under this agreement to vest in order to be valid under the rule against perpetuities. For such purposes, my Trustee may enter into any contracts, covenants and warranty agreements that my Trustee deems appropriate."
- 8. The other provisions of the trust are of a personal nature and set forth the distribution of trust property. They do not modify the powers of the trustee.
- 9. The trust agreement has not been revoked.
