

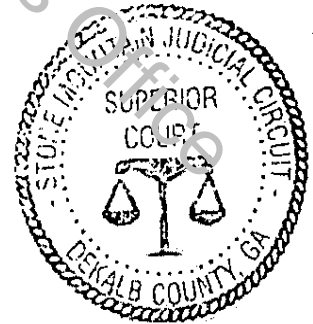

Company Resolution – Authorization – Power of Attorney

KNOW ALL MEN BY THESE PRESENTS:

That Altisource Residential, L.P., on behalf of itself and its subsidiaries including, without limitation, its Delaware statutory subsidiaries listed on attached Exhibit A, for which Altisource Residential, L.P. is the Administrator (individually and collectively, the "Company"), having its principal office located at 1110 Strand Street, Suite 2A, Christiansted, Virgin Islands 00820, in furtherance of the Master Services Agreement between Altisource Residential Corporation, the ultimate parent of the Company, and Altisource Solutions S.à.r.l., does hereby irrevocably resolve, make, constitute and appoint Altisource Solutions S.à.r.l. and Mia Alexander, as signatories and its true and lawful attorneys-in-fact:

The above entity and/or persons shall have the authority to transact the following business for the Company, either alone or together:

The right to manage the real property owned by the Company in the United States ("Property") and to contract for the sale and execution of all documents necessary to manage, sell or transfer the Property. This includes the following rights and powers:

- 1) *To act in place of the Company for all matters related to Property, including the management, listing, leasing, purchasing, or selling of Property and to assign and appoint persons within Altisource Solutions, S.à.r.l. or its subsidiaries to be signatories on its behalf to carry out any rights and powers indicated herein.*
- 2) *The authority to execute listing agreements, listing addenda and market Property;*
- 3) *To execute all documents in relation to the management, sale, transfer, grant, conveyance, bargaining, or other similar disposition of Property;*
- 4) *To execute and deliver a Special Warranty Deed, Bargain and Sale Deed, Grant Deed, Warranty Deed or Quit Claim Deed conveying Property to a third party;*
- 5) *To sign, on the Company's behalf, settlement statements, disclosure statements, acceptance statements, affidavits concerning mechanic's liens; assignment of security deposits, extensions of the contract for purchase and sale, and any and all other documents and instruments required as part of the closing function related to the sale of Property ("Property Closings"); and*
- 6) *To disburse, receive, manage and control money, funds, and credits pertaining to Property Closings; AND in general I give my said attorney in fact full power to handle Property Closings in such manner and with such authority as the Company might exercise, including the power to make, execute, and acknowledge instruments of every kind which may be proper or requisite to effectuate all or any of the premises contained herein.*

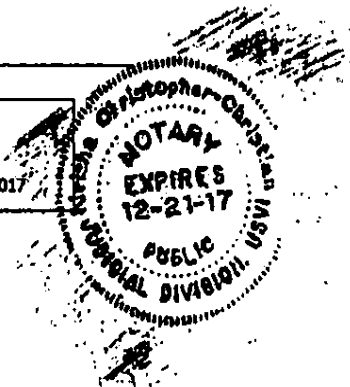
