The undersigned lien claimant, **PANIAGUA GROUP**, **INC.** ("Paniagua"), with an office at 2420 E. Oakton Street, Unit G, Arlington Heights, Illinois 60005, hereby records a Subcontractor's Claim For Lien against **HARVEST HOMES APARTMENTS**, **LP**, 3750 W. Fifth Avenuc, Chicago, Illinois 60624 ("Owner"), its Lender **JP MORGAN CHASE BANK**, c/o CT Corporation 208 S. LaSalle Street, Suite 814, Chicago, Illinois 60604, its General Contractor **POWERS & SCNS CONSTRUCTION COMPANY**, **INC.**, 5040 S. State Street, Chicago, Illinois 60609, General Contractor's other subcontractor **SACO INDUSTRIES**, **INC.** 17151 Morse Street, Lowell, Indiana 46356, and all other persons or entities having or claiming an interest in the below-described real estate. In support, Paniagua states as follows:

- 1. On or before December 21 2015, Owner owned a parcel of real estate in the County of Cook, State of Illinois described in Exhibit A attached hereto, commonly known as 3512-3542 West Fifth Avenue, Ch cago, Illinois and 318-322 South St. Louis Avenue, Chicago, Illinois 60624 (PIN Nos. 16-14-214-024-0000, 16-14-214-028-0000, 16-14-214-030-0000) (collectively, the "Property").
- 2. On or before December 21, 2015 Owner entered into a general contract with Powers & Sons Construction Company as "Contractor" (the "Contract"), wherein Contractor was to provide labor, materials, and equipment relating to the construction of four residences known as the Harvest Homes on the Property (the "Project").
- 3. On or about August 19, 2016, with the knowledge and consent of the Owner, Contractor entered into a Subcontract Agreement with Paniagua for Subcontract No. 14026-18 (the "Subcontract"), wherein Paniagua was to provide labor and materials to satisfy Contract Specification Sections 96513 (Resilient Wall Base and Accessories), 96519 (Resilient Floor Tile), and 96816 (Carpet) as described therein (the "Work") at the Project. According to the Subcontract, the lump sum amount to be paid to Paniagua for the Work was \$266,000.00 (the "Contract Sum").
- 4. On February 7, 2017, Paniagua performed its last day of Work required by the contract to be done as of that date, including \$25,107.00 in approved extra and changed Work, such that the adjusted Contract Sum of \$291,107.00 became due and owing.
- 5. The Owner has left unpaid, due and owing to Paniagua, after allowing all credits, the sum of \$157,316.00 for which, with interest, Paniagu claims a lien on the Property and improvements and to monies or other considerations due or to become due from Owner under the Contract.

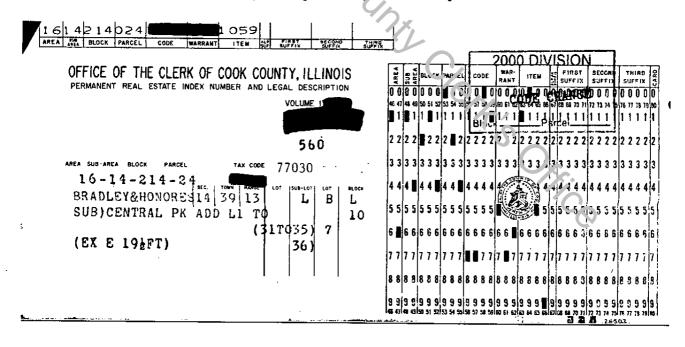

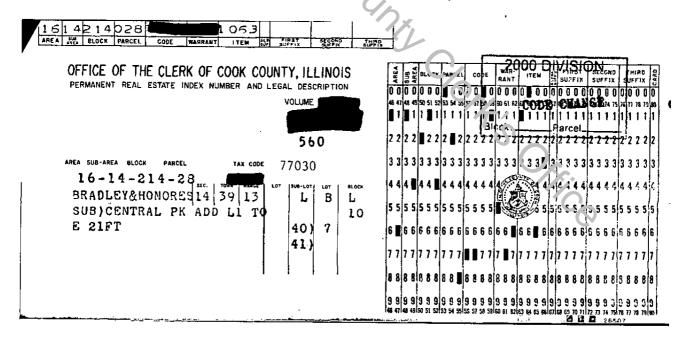

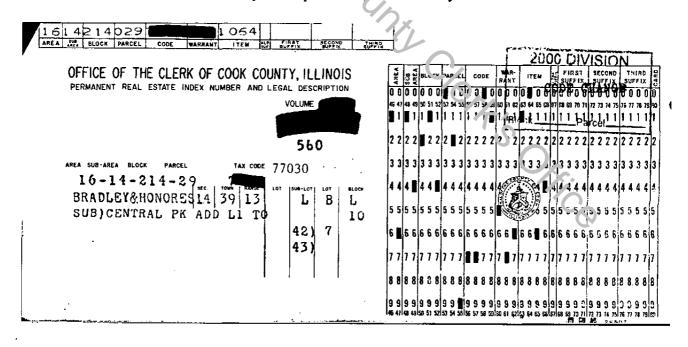
