

PROPERTY DESCRIPTION

The following described real estate situated in the County of Cook, in the State of Illinois, to wit:

That part of Lot 228 in Bristol Park Unit Two, a subdivision of part of the Northwest 1/4 of section 36, Township 36 North, Range 12, East of the Third Principal Meridian, bounded and described as follows:

Commencing at the Southwest corner of said Lot 228; thence Northerly along the Westerly line of said Lot 228, being a curved line concave Westerly and having a radius of 1242.50 feet, the center of circle being a point that is 1101.00 feet South of the North line of said Northwest 1/4 and 1101.00 feet east of the west line of said northwest 1/4 (said center of circle hereinafter described as point "A"), an arc distance of 99.06 feet to the point of beginning; thence continuing along said westerly line of lot 228, an arc distance of 39.06 feet to the northerly line of said lot 228; thence south 86 degrees, 18 minutes 37 seconds West, along the Northerly line of said Lot 228, 123.00 feet to the Easterly line of said Lot 228; Thence Southerly along the Easterly line of said Lot 228, being a curved line concave Westerly and having a radius of 1365.50 feet, the center of circle being said point "A", an arc distance of 45.89 feet; thence South 89 Degrees, 29 minutes, 41 seconds west 123.03 feet to the point of Beginning, all in Cook County, Illinois.
