SECOND AMENDMENT TO DECLARATION OF CONDOMINIUM PURSUANT TO THE CONDOMINIUM PROPERTY ACT 1440 N. CAMPBELL AVENUE CONDOMINIUM

This Second Amendment to Declaration ("First Amendment") is made and entered into this <u>23</u> day of April, 2017, by Thomas M Battista, Mathew J Degutes, Ryan Closser, and Scott Ryan, being all of the Unit Owners of the 1440 N. CAMPBELL AVENUE COMPOMINIUM

(hereinafter sometimes referred to as the "Unit Owners"): WITNESSETH:

WHEREAS, by Declaration of Condominium for the 1440 N. CAMPBELL AVENUE CONDOMINIUM dated November 2, 2004 and recorded in the Recorder's Office of Cook County, Illinois on November 10, 2004 as Focument No. 0431519030, the real estate commonly known as 1440 N. Campbell, Chicago, Illinois and legally described in Exhibit "A" attached hereto, was submitted to the provisions of the Illinois and office and ominium Property Act as more fully set forth therein. Capitalized words not defined in this First Amendment have the meaning ascribed to such terms in the Declaration; and

WHEREAS, pursuant to Section 8 of the Declaration the members of the Board and Unit Owners have the right to amend the Declaration and the members of the Board and the Unit Owners now desire to amend the Declaration to change the percentage of ownership shared by said owners.

NOW, THEREFORE, pursuant to the power coupled with the interest provided to the members of the Board and the Unit Owners reserved in the Declaration, the members of the Board and Unit Owners do hereby amend the Declaration as follows:

1. Section 2.04, and related Exhibit C to the Declaration concerning the percentage of ownership of the common elements. From this date forward, the percentage of ownership shall be as follows:

Unit 1 – 27.61 percent Unit 2 – 27.55 percent Unit 3 – 30.40 percent Garden Unit 14.44 percent
