Dear Mr. Dukech,

Per Chapter 7, Anticle IV (Storm Water Management) of the Village Code of Northfield, any new development or series of developments covering an area of 1,000 square feet or more shall provide storm water detention to accommodate storm water run-off in accordance with the requirements of the Village Code. Any development which would result in less than 1,000 square feet of additional impervious ground coverage shall be required to contribute to the Village a monetary amount in lieu of storm water detention.

We have reviewed the revised engineering plans received 4-27-16 for construction a new single family residence and have determined the net new impervious ground coverage to be 407 square feet. The fee for the additional 407 square feet at \$4.50 per square foot is \$1,831.50 plus a \$100.00 recording fee, for a total of \$1,931.50

Any future development on this property of 593 square feet or more will require that detention be provided. That detention facility shall have a minimum capacity to mitigate the full 1,000 square feet of impervious ground coverage.

By the current property owners signing this document and it being recorded current and future owners will be placed on notice that any future development on this property of 593 square feet or more by current or future owners will require that the necessary derention be provided.
