#### MORTGAGE

This Mortgage ("Mortgage") is made as of the \_\_\_\_day of May, 2017, between Elite Invest, LLC Series 1050 ("Mortgagor"), 404 S. Wells St., 2<sup>nd</sup> Floor, Chicago, IL 60607 and Sherry's Way IRA Investments, LLC ("Lende.' or "Secured Party," as applicable), 315 W/ 60% N., Lindon, UT 84042

WITNESSETH: Mortgagor in evocably grants, conveys, transfers, and assigns to Lender that real property in Cook County, Illinois commonly known as <u>9539 S. Euclid Ave., Chicago, IL 60617</u> (the "Property") legally described in Exhibit A, attached hereto.

- II. TO PROTECT THE SECURITY TO THIS MORTGAGE, MORTGAGOR COVENANTS AND AGREES AS FOLLOWS:
- 1. Payment of Principal and interest. Mortgagor shall pay, when due, the principal of and interest on the indebtedness evidenced by the Note, any fees and costs provided in the Note, and all other sums secured by this Mortgage.
- 2. Application of Payments. Unless applicable law requires otherwise, all payments received by Lander from Mortgagor under the Note or this Mortgage shall be applied by Lender in the following order of priority: (a) costs payable as provided in the Note; (b) interest payable on the Note; and (c) principal of the Note.
- 3. Charges, Lizas: Mortgagor shall pay all water and sewer rates, rents, taxes, assessments, insurance premiums and other impositions attributable to the Property, when due, directly to the appropriate payee.
- 4. Hazard Insurance. Mort agor shall keep the improvements now existing or hereafter erected on the Property insured by carriers and times satisfactory to Lender against loss by fire, hazards included within the term "extended core age," and such other hazards, casualties, liabilities, and contingencies as Lender shall require. All premiums on insurance policies shall be paid by Mortgagor making payment, when due, directly to the carrier.
- a. All insurance policies and renewals there of shall be in a form acceptable to Lender, shall include a standard mortgagee loss payable clause in a form acceptable to Lender. When requested by Lender, Mortgagor shall promptly furnish to Lender written evidence of such insurance policies, all renewal notices and all receipts of paid premiums. At least thirty (30) days prior to the expiration date of a policy, Mortgagor shall deliver to Lender a renewal policy in form satisfactory to Lender.
- b. In the event of any loss covered by any such policies, Mortgago shall give immediate written notice to the insurance carrier and to Lender.
- Preservation and Maintenance of Property. - 6. Protection of Lender's Security. If Mortgagor fails to perform and of the covenants and agreements contained in this Mortgage, or if any action or proceeding is commenced that affects the Property or title thereto or the interest of Lender therein, including, but not limited to, eminent domain, insolvency, building code enforcement, or arrangements or proceedings involving a bankrupt or decedent, then Lender at Lender's option may make such appearances, disburse such sums, and take such action as Lender deems necessary, in its sole discretion, to protect Lender's interest, including, but not limited to disbursement of attorneys' fees, entry upon the Property to make repairs or otherwise to protect the Property as security for the indebtedness secured by this Mortgage; and procurement of satisfactory insurance as provided in paragraph 4 hereof.
- a. Asy amounts disbursed by Lender pursuant to this paragraph 6 shall become additional indebtedness secured by this Mortgage and shall bear interest at the rate of four percent (4%) per annum from the date(s) disbursed by Lender to the date(s) paid by Mortgagor to Lender.
- 7. Condemnation. Moragager shall promptly notify Lender of any action or proceeding relating to any condemnation or other taking of the Property, or part thereof, and Mortgagor shall appear in, and prosecute any such action or proceeding. - Acceleration in Case of Insolvency.
