THAT, at all relevant times, Wheeling Assisted Living, LLC, and Wheeling Memory Care, LLC, and all other(s) owning or claiming an interest in the hereinafter-described real property, or any of them, was (were) the owner(s) of the following-described real property, to-wit:

THAT, on July 27, 2016, Claimant entered into a subcontract with the said Lake Superior Contracting, L.P., to fabricate and erect structural steel for the afore-described real property of a value of and for the sum of \$429,500.00.

THAT, at the subsequent request of the said Lake Superior Contracting, L.P., and further pursuant to the said subcontract, Claimant fabricated and erected additional structural steel and provided engineering services for the afore-described real property of a value of and for the sum of **\$66,020.00**.

THAT, as of the date of filing of the instant instrument, Claimant's performance pursuant to the said subcontract is ongoing, and that the last date on which Claimant provided substantial labor or material pursuant to the said subcontract was March 7, 2017.

THAT the value of labor and/or material required of Claimant pursuant to the said subcontract but to date not provided by Claimant is \$30,520.00, for which sum Claimant, solely for purposes of calculating a balance due and claim sum as of the date of filing of the instant instrument, issues a tentative credit against the subcontract price.
